10.3. Aggressive Fouls, Dangerous Play and Abusive language
RED card Offences
A player must not:
a. Strike an opponent with the hurley
b. Strike an opponent with the arm, elbow, hand, knee or head
c. Punch an opponent
d. Kick an opponent
e. Stomp on an opponent
f. Spit at an opponent or official
g. Contribute to a melee
h. Assault any official
i. Interfere with the faceguard of an opponent's helmet
j. Use abusive or threatening language or gestures or any conduct by deed,
word or gesture of threatening, or racist nature or which is contrary to the
principles of inclusion and diversity against a player, official, mentor, spectator
or anyone else, in the course of activities organised by the Association, to a
Referee, match officials, players or mentors
k. Use the hurley to 'dig' an opponent
I. Interfere with an opponent's helmet
m. Behave in any way that is dangerous to an opponent.

10.2. Rough play and Dissent
Yellow card Offences
A player must not:
a. Deliberately shoulder an opponent other than shoulder to shoulder
b. Trip, catch or hold an opponent
c. Charge directly into an opponent's body with or without the sliotar
d. Reach from behind with the hurley or around the body of an opponent which
is not consistent with an attempt to play the ball
e. Throw the hurley
f. Engage in any form of rough play
g. Challenge the authority of a referee/match officials
h. Attempt to strike an opponent with or without hurley
i. Attempt to kick an opponent
j. Play without a helmet
k. Use a hurley of incorrect size
I. Use the hurley to obstruct an opponent
m. engage in persistent personal fouling

You are requested to:

- a) Be at the venue one hour before the start of the game
- b) Arrange Umpires for the Match
- c) Complete this form and return it (together with team sheets) within 6th calendar day after the match, unless a player is dismissed from the field of play with a straight red card. The referee report in this case must be submitted on Official Form CC5, together with signed Team Lists, on or before the second calendar day after the date of the match.
